RECOGNIZING THE LIES

In the Word we read: My people are destroyed from lack of knowledge. (Hosea 46:a)

The enemy is desperate to keep us in deception and without knowledge of the truth that and access to the Kingdom realm. As long as we are unaware of the legal rights he has against us, he will continue to torment and destroy our lives and the lives of those we love. He will work overtime to create doubt that the Kingdom Courts are real and available and accessible right now. The church will debate and react in fear of hearsay and deny themselves a powerful tool.

So much of my journey in *Marching Around Jericho* was tearing down fear and religiosity. I had to confront the naysayers and all those who threw up doubt about ministries and teaching that other believers were convinced was not biblical or of God. I was so desperate, however, for a move of God's hand, that I was willing to face the fears and ask the Lord Jesus to teach me.

And He did! Hallelujah.

My journey entailed riding my faith of "religious nonsense." And walking through this season, I could relate to Jesus as He was always confronting the Pharisees. My friends, to gain this very powerful tool, you will confront the pharisaical beliefs as well. But the result, once you have, is out of this world! Truly!

TRUTH

So Jesus said to the Jews who had believed him, "If you abide in my word, you are truly my disciples, and you will know the truth, and the truth will set you free." —John 8:31-32 (ESV)

Ask Jesus for the truth about our access to the Kingdom courts. Access because we are seated with Christ in the heavenly realms (Ephesians 2:6)

The court of accusation is a place where we receive mercy and restitution upon repentance. Repentance and forgiveness are the keys to releasing God's hand to move in your life. Without these the enemy continues to hold us captive.

Additionally, through covenant relationships such as marriage, children, church memberships, etc., we can pray and seek God's mercy and blessing just as Daniel did for Israel. Our covenants are highly recognized in the spiritual realm and absolutely respected. Stand upon your love for someone and ask for God's hand of mercy. Offer substitutional repentance. What can it cost you but some time and words?

Pray right now and ask the Lord, Jesus, bring to my mind those whom I have a love/covenant relationship with that I could bring to the Court of heaven and offer repentance and ask for mercy? Write down those names, including your own, and plan to take them to the Court of Accusation to bring relief from the demonic strongholds in their lives.
